




Encompass Server

Maintaining the security and integrity of the digital record



VIQ's multi-tiered Encompass Server solution provides secure, synchronized audio and video capture and management for large-scale installations. Encompass Server provides a redundant record that is easy to store, search and share, even across networks with hundreds of locations across the country.

The Encompass Server process is simple and automated. Encompass Server is fully integrated with case management systems, automatically copying information from the case management database to create a case list for the presiding judge. To start recording, the judge selects the current case from the list and recording begins automatically, fully populated with the information from the case management database.

Each Encompass PC records the audio and case information locally on their own hard drive. Once recording is complete, Encompass Server's automated synchronization process takes over, copying audio and case information from each recording workstation to their assigned Middle Tier server, automatically creating a secondary copy of each case.

The audio and case information is then automatically synchronized from the Middle Tier servers to the Central Server, which houses all the audio and case information for the entire network. From the Central Server, administrators can create CD/DVDs of audio and case information for distribution or additional backup.

RecordIAB Suite: An easy way for analog users to make the jump to digital audio and video recording.

The RecordIAB suite of solutions puts standalone digital audio and video recording and management at your fingertips. With easy to use, tape recorder-style controls, RecordIAB solutions are ideally suited for entry-level users or users replacing analog tape systems.

RecordIAB comes in three solutions: the **VIQ Shuttle DRA**, an all-in-one console solution; the **VIQ Shuttle** (shown below), a small form-factor PC that works with a range of audio capture devices; and **RecordIAB SE**, a software-only solution that can be installed on the PC of your choice.

Flexible enough for fixed locations or portable use, Encompass works with a range of audio and video capture devices to provide a complete solution for any budget or situation.

Our enterprise-level digital audio solution for courthouses, CourtFLOW provides effortless digital recording, remote video monitoring, instantaneous retrieval and playback of any case audio, plus secure storage. CourtFLOW can provide simultaneous digital recording of all of your courtrooms and can be managed from one central location or from individual courtrooms. For backup and storage purposes, CourtFLOW supports archiving to BrightStor ARCserve and Symantec Backup Exec data protection solutions.

The CourtFLOW Scheduling Module allows a single operator to schedule and control recording in all the courtrooms on the CourtFLOW system. The administrator can create one-time or recurring events and let the Scheduling Module handle the recording process automatically.

The AccessPOINT Portal provides judges, lawyers, and other authorized parties with secure, password-protected access to court recordings, annotations, and transcription services from their office, home computer, or any computer with an Internet connection.
